AUDIT REPORT ON IMPLEMENTATION OF THE BSEC-URTA BUDGET FOR 2010

- 1. In compliance with the decision of the Seventeenth Meeting of the BSEC-URTA General Assembly (DEC/GA17/10) and the related provisions of the BSEC-URTA Financial Regulations (REG/GA06/FIN/04); the implementation of the BSEC-URTA Budget for 2010 by the International Secretariat, was audited and this audit report was prepared and undersigned by the following Auditors, who were elected at the abovementioned meeting of the BSEC-URTA General Assembly:
 - Ms. Viliana Ivanova, AEBTRI (Bulgaria)
 - Mr. Aybek Abdrakhman, UND (Turkey)

The BSEC-URTA International Secretariat was informed by the International Transporters' Association (UND) that Mr. Aybek Abdrakhman has left the UND and he is replaced by Mr. Alper Özel, Member of the Executive Committee.

2. The representatives of the BSEC-URTA International Secretariat and BSEC-URTA Accountant Mr. Irfan Bilgin also participated in the work of the BSEC-URTA Auditors, as necessary.

4. BSEC-URTA Accounting System

The official accounts are held by an external accountant, who works for the BSEC-URTA on part time basis. Official accounting records are kept in the computer under a special accounting program in local currency and language according to the provisions of Turkish legislation. However, the International Secretariat holds unofficial accounting records of its financial transactions in € currency and English language parallel with the structure of BSEC-URTA budgets so that the control and audit of BSEC-URTA accounts can be carried out, easily, by the appointed BSEC-URTA Auditors.

5. BSEC-URTA Revenues

- Contribution fees of Member Associations as approved by BSEC-URTA General Assembly
- Observer fees as approved by BSEC-URTA General Assembly
- IRU Contribution
- Interests accrued from the BSEC-URTA accounts
- Other

The Contribution Fees of the Member Associations and Observer fees for the subsequent year are decided by the Autumn Session of the General Assembly. Upon request of BSEC-URTA, IRU also confirms about level of its contribution to the BSEC-URTA budget before the end of previous year.

After approval of its budget for the next year, the International Secretariat informs the BSEC-URTA Member Associations and Observers about amount of their contribution fee and the necessary banking details.

Upon receipt of a contribution fee into its accounts, BSEC-URTA International Secretariat issues a receipt and records the amount of transfer under its accounting software. Such received amounts are kept under the official bank accounts, as demand or time deposits according to daily office needs.

6. BSEC-URTA Expenses

The International Secretariat executes the BSEC-URTA budget according to amounts approved by the General Assembly and in compliance with the BSEC-URTA Financial Regulations, which were adopted in Tbilisi at 6th Meeting of the BSEC-URTA General Assembly.

7. BSEC-URTA Budget Composition

Budget of the BSEC-URTA International Secretariat is composed of six principal chapters:

- Expenses related to the Staff of the International Secretariat
- Administrative and Office Expenses
- Expenses related to activities
- Program Funds
- Investments
- Contingency

Each spending or expense is documented as a rule and annexed to an internal Expense Authorization Form, as an evidence of abovementioned approval process. All such documentation is archived in the folders classified according to principal chapters of the BSEC-URTA budget.

8. BSEC-URTA Financial Results for 2010

The BSEC-URTA Auditors noted the information and controlled the financial documentation for 2010, as provided by the BSEC-URTA International Secretariat, and noted the BSEC-URTA Financial Results for 2010 as follows:

9. Audit Notes

The Auditors checked the financial documentation and held meetings with the BSEC-URTA Staff in full freedom and friendly atmosphere.

As a result of audit, it was witnessed and confirmed that all the transactions were recorded, the documentation was full and the accounting records were in compliance with BSEC-URTA statutory documents and generally accepted accounting principles.

The followings were noted during analysis of the financial tables for 2010:

- Saving was noted in an amount of:
 - € 1003.43 under "Expenses related to activities"
 - € 26,666.54 under "Program Funds"
 - € 2511.31 under "Contingency"
- An over-spending was noted in an amount of:
 - € 10661.29 under "Expenses related to the Staff of the International Secretariat"
 - € 1390.20 under "Administrative and office Expenses"
 - € 534.99 under "Investments"

According to the above, a total saving of €17.594.80 was realized under the Budgetary items in 2010

It was noted that the contribution fees for 2011 of OFAE, UND and ABADA have not been received yet. Taking into account that the deadline for payment of the above mentioned contributions was 31 January 2011 and in compliance with the BSEC-URTA Financial Regulation, Section II, Article 5 and 7, the Auditors asked the International Secretariat of BSEC-URTA to address in writing the a/m associations until 15 March 2011, in order to clarify this matter.

It was also noted that some of the arriving contribution fees for 2010 were incomplete due to the bank charges, and the Auditors have agreed to draw attention of the BSEC-URTA Member Associations to the fact that the

BSEC-URTA Budget is calculated according to the net amount of contribution fees and the Member Associations are responsible to transfer their fees in complete.
