## FIFTH MEETING OF THE BSEC-URTA GENERAL ASSEMBLY

Crowne Plaza Hotel, Bucharest – ROMANIA Thursday 24 June 2004, at 10:00 hrs

## DECISIONS

At its Fifth Meeting, held in Bucharest on 24 June 2004, the BSEC-URTA General Assembly:

- 1. Approved the Minutes of its Fourth Meeting (MIN/GA04/03),
- 2. Upon request of some Member Associations, included in its Agenda the issue of new transit taxes introduced by the Hungarian Government as of 1st May 2004 and adopted a resolution (RES/GA05/HUN/04) on this subject (Annex 1), with the abstention of ASMAP and AIRCU,
- 3. Adopted the Resolution on the Professional Visa for Drivers (RES/GA05/BVPD/04) with the inclusion of a new operative article no. 4 (Annex 2),
- 4. Adopted the Resolution on the International Vehicle Weight Certificate (RES/GA05/IWC/04) (Annex 3),
- 5. Adopted the Resolution on the Distant Professional Training (RES/GA05/TRAIN/04) (Annex 4),
- 6. Asked the International Secretariat to prepare a report about the content, objectives and timetable for realisation of the Black Sea Transport and Logistics Guide and circulate it to the Member Associations until the end of July 2004, and requested the Member Associations to provide written comments with and give active support to the International Secretariat for the preparation and promotion of the Guide,
- 7. Welcomed the succesful organization of the International Transport Forum in Bucharest on 23 June 2004 and expressed its support to the Declaration adopted whereof (Annex 5),
- 8. Decided to postpone the consideration of BSEC-URTA Financial Regulations and possible modification of BSEC-URTA Statutes to its next meeting,
- 9. Elected Mr. Manuel Trifanciuk (ARTRI) and Mr. Nicolaras Panagiotis (OFAE) as the BSEC-URTA Auditors for 2004,
- 10. Accepting the kind invitation of GIRCA, decided to hold its next meeting in Tbilisi (Georgia) on 26 October 2004.
